The following conditions apply to the Health2Holland Programme:

- 1. Registration for the Health2Holland Programme presupposes acceptation of these conditions and the <u>Branch Unlimited Privacy Policy</u>, that also applies to the Health2Holland Programme.
- 2. A registration for the Health2Holland Programme is deemed to be completed if the web registration form has been filled out and Branch Unlimited has received a notification of that entry.
- 3. Branch Unlimited will confirm the registration within 24 hours upon receipt of the registration.
- 4. Participants may choose if they want to participate only in the Core Programme, or in both the Core Programme and the Extended Programme. The Core Programme consists of 5 online masterclasses. The Extended programme consists of:
 - a. a live meeting with investors;
 - b. a live meeting with representatives of the Academic Hospital Utrecht;
 - c. a pitch training;
 - d. the possibility to visit the Health & ICT Trade Show.
- 5. The programme fees are:
 - a. Core Programme: € 1.995,=.
 The fee for the Core Programme costs cover the participation in the online masterclasses for a maximum of 3 participants per company.
 - b. Extended Programme: € 750,= per participant.

 The fee for the Extended Programme covers the participation of 1 participant per company. For every extra participant of a company, the company pays € 375,=. The number of extra participants in the Extended Programme, can be confirmed via email ultimately 1 June 2023.

 The fee for the Extended Programme covers participation in the programme parts as mentioned in 3 a-d, lunch costs and the costs of dinner for 2 nights. All other costs, notably hotel costs and the costs for travel to and in Utrecht, are to be covered by the participating company.
- 6. Branch Unlimited will send an invoice for participation within a week after registration. The invoice has to be paid in full before the start of the Health2Holland Programme. Participation is not allowed if the invoice has not been paid.
- 7. Branch Unlimited is entitled to cancel the Health2Holland Programme if less than 6 companies have registered. Fees that already have been paid for, will be fully reimbursed to the company.
- 8. Branch Unlimited is entitled to make changes to the program as stated in the brochure, based on the principle that changes are aimed at maintaining or

improving the quality of the programme. Changes will be communicated timely with participants.

- 9. No later than 1 week prior to the date of the first (online) meeting, Branch Unlimited will let registered participants know whether the program will take place or not.
- 10. By registering for the Health2Holland Programme, participants guarantee that any confidential business information, strategies, etc. that may be shared during the Health2Holland Programme, will not be shared with third parties.
- 11. Participants make an effort to contribute to the success of the Health2Holland Programme through active participation in the individual sessions or by sufficiently preparing for sessions, if asked.
